Dear Mr. Sajo:

This is a Final Order by Default issued by the Secretary of State (secretary) for your failure to file a sufficient September initiative drive contribution and expenditure report for 2004.

On June 3, 2005, the secretary notified A Life With Dignity Committee (committee), pursuant to ORS 260.232(2), that it had failed to file a sufficient report and that the secretary may impose a civil penalty. An opportunity for a hearing was provided in that notice; however, no request for a hearing was received by the secretary within the time permitted in the notice. Accordingly, after consideration of the records and files of the secretary regarding this matter, the secretary is entering the following Order.

FINDINGS OF FACT

1. The committee's Statement of Organization (SEL 221), applicable during the reporting period, was filed with the secretary on February 14, 2003. The statement reported John A. Sajo as the treasurer and PO Box 3586, Portland, OR 97208 as the address to which all committee correspondence was to be sent.
2. The committee filed a September initiative drive report for 2004 with the secretary on September 11, 2003.
3. On September 25, 2003, the secretary sent the committee an exam letter that itemized the areas where the report was not in compliance. The committee was asked to submit the necessary amended information by October 9, 2003, to avoid penalties for failure to file a sufficient report.

4. On the day following the October 9, 2003, amendment deadline, the committee's report was still missing the following required information: a complete date within the accounting period for one expenditure (1 item). (The proposed penalty notice of June 3, 2005, erroneously stated "a date within the accounting period for one contribution". It is actually an expenditure.)
5. On September 9, 2004, the committee amended its Statement of Organization, updating the address for committee correspondence to 4315 SE Division St, Portland, OR 97206.
6. On June 3, 2005, the secretary sent the committee a Notice of Proposed Civil Penalty. The notice was sent by both certified and first class mail to the treasurer at PO Box 3586, Portland, OR 97208 address. The notice proposed a civil penalty of \$10.00 and allowed the committee 20 days to request a hearing. The notice sent by certified mail was received and signed for by the committee on June 6, 2005.
7. The committee did not request a public hearing or submit notarized testimony in lieu of a public hearing.
8. The secretary has record of no previous insufficient filings during the two-year period beginning September 15, 2001.

#### ULTIMATE FINDINGS OF FACT

John A. Sajo, Treasurer, failed to file a sufficient September initiative drive contribution and expenditure report for 2004.

#### CONCLUSIONS OF LAW

Treasurer John A. Sajo's failure to file a sufficient September initiative drive contribution and expenditure report for 2004 violated ORS 260.118, ORS 260.083 and OAR 165-012-0005. A civil penalty may be imposed for this violation under ORS 260.232(1)(b).

A maximum \$10,000 civil penalty may be imposed for this violation. The *2002 Campaign Finance Manual*, which contains a penalty calculation matrix on pages 98 and 99, is designated in OAR 165-012-0005 as the procedure manual for Oregon campaign finance regulations.

Since this is the first violation by the treasurer, the penalty is \$10.00 per omission.

#### ORDER

It is ordered that no penalty be assessed because the appropriate penalty is under \$50.

RIGHT TO JUDICIAL REVIEW

You have the right to appeal this Order to the Oregon Court of Appeals pursuant to ORS 183.482. To appeal you must file a petition for judicial review with the Court of Appeals within 60 days from the day this Order was served to you. Because this Order was mailed to you, the date of service is the day it was *mailed*, not the day you received it. If you do not file a petition for judicial review within the 60-day time period, you will lose your right to appeal.
