Dear Mr. Kropf:

This is a Final Order by Default issued by the Secretary of State (secretary) for your failure to file a sufficient supplemental contribution and expenditure report for 2005.

On August 1, 2007, the secretary notified Jeff Kropf for State Representative (committee), pursuant to ORS 260.232(2), that it had failed to file a sufficient report and that the secretary may impose a civil penalty. An opportunity for a hearing was provided in that notice; however, no request for a hearing was received by the secretary within the time permitted in the notice. Accordingly, after consideration of the records and files of the secretary regarding this matter, the secretary is entering the following Order.

FINDINGS OF FACT

1. The committee's Statement of Organization (SEL 220), applicable during the reporting period, was filed with the secretary on February 19, 2004. The statement reported Laverne Saboe as the treasurer and PO Box 130, Sublimity, OR 97385 as the mailing address for both candidate and committee correspondence.
2. The committee filed a supplemental report with the secretary on September 12, 2005.
3. On September 27, 2005, the secretary sent the committee an exam letter that itemized the areas where the report was not in compliance. The committee was asked to submit the necessary amended information by October 10, 2005, to avoid penalties for failure to file a sufficient report.

4. On the day following the October 10, 2005, amendment deadline, the committee's report was still missing the following required information: a date within the accounting period for one contribution, sufficient occupational information for two contributors, the dates within the accounting period for two personal expenditures and sufficient purposes for two expenditures (7 items).
5. On October 18, 2005, an amendment to the committee's report was filed. The amendment provided six items of previously insufficient information.
6. On August 1, 2007, the secretary sent the committee a Notice of Proposed Civil Penalty. The notice was sent by both certified and first class mail to the candidate and was sent by first class mail to the treasurer at 4181 Cascade Hwy, Sublimity OR 97385 because mail was being returned. The notice proposed a civil penalty of \$80.00 and allowed the committee 20 days to request a hearing. The notice sent by certified mail was received and signed for by Jeff Kropf on August 2, 2007.
7. On September 7, 2007, the committee filed an amended statement of organization changing the Jeff Kropf to the Treasurer. Also changed was the mailing address for the Treasurer and Candidate to PO Box 130 Sublimity OR 97385.
8. The committee did not request a public hearing or submit notarized testimony in lieu of a public hearing.
9. The secretary has record of two previous insufficient filings during the two-year period beginning September 15, 2003.

ULTIMATE FINDINGS OF FACT

Jeff Kropf, Candidate, and Laverne Saboe, Treasurer, failed to file a sufficient supplemental contribution and expenditure report for 2005.

CONCLUSIONS OF LAW

Candidate Jeff Kropf's and Treasurer Laverne Saboe's failure to file a sufficient supplemental contribution and expenditure report for 2005 violated ORS 260.068, ORS 260.083 and OAR 165-012-0005. A civil penalty may be imposed for this violation under ORS 260.232(1)(b).

A maximum \$10,000 civil penalty may be imposed for this violation. The *2004 Campaign Finance Manual*, which contains a penalty calculation matrix on pages 104 and 105, is designated in OAR 165-012-0005 as the procedure manual for Oregon campaign finance regulations.

Since this is the third violation by the candidate, the penalty is \$20.00 per omission, less 50% for every omitted item provided prior to the issuance of the proposed penalty notice.

ORDER

Payment of the proposed civil penalty of \$80.00 was received in the office of the Secretary of State on September 28, 2007. This Order will serve as your receipt and this matter is now considered closed.

RIGHT TO JUDICIAL REVIEW

You have the right to appeal this Order to the Oregon Court of Appeals pursuant to ORS 183.482. To appeal you must file a petition for judicial review with the Court of Appeals within 60 days from the day this Order was served to you. Because this Order was mailed to you, the date of service is the day it was *mailed*, not the day you received it. If you do not file a petition for judicial review within the 60-day time period, you will lose your right to appeal.
