Dear Mr. Swanson:

This is a Final Order by Default issued by the Secretary of State (secretary) for your failure to file a sufficient post election contribution and expenditure report for the May 16, 2006, Primary Election.

On June 20, 2008, the secretary notified the Oregon Federation of College Republicans (committee), pursuant to ORS 260.232(2), that it had failed to file a sufficient report and that the secretary may impose a civil penalty. An opportunity for a hearing was provided in that notice; however, no request for a hearing was received by the secretary within the time permitted in the notice. Accordingly, after consideration of the records and files of the secretary regarding this matter, the secretary is entering the following Order.

FINDINGS OF FACT

1. The committee's Statement of Organization (SEL 221), applicable during the reporting period, was filed with the secretary on January 23, 2006. The statement reported Keith Bryan as the treasurer and 2770 E. 16<sup>th</sup> Ave, Eugene, OR 97403, as the address to which all committee correspondence was to be sent.
2. John Swanson filed a post election report with the secretary on June 15, 2006.
3. On June 30, 2006, the secretary sent the committee an exam letter that itemized the areas where the report was not in compliance. The committee was asked to submit the necessary

amended information by July 13, 2006, to avoid penalties for failure to file a sufficient report.

4. On the day following the July 13, 2006, amendment deadline, the committee's report was still missing the following required information: sufficient occupational information for one contributor and the sufficient purposes for five expenditures (6 items).
5. On January 2, 2007, the secretary received a statement of organization naming John Swanson, treasurer, and updating the committee mailing address to PO Box 789, Salem, OR, 97308.
6. On June 20, 2008, the secretary sent the committee a Notice of Proposed Civil Penalty. The notice was sent by both certified and first class mail to John Swanson c/o Benjamin Garrett, 3680 Browns Creek Rd, The Dalles, OR, 97058. The notice proposed a civil penalty of \$60.00 and allowed the committee 20 days to request a hearing. The notice sent by certified mail was received and signed for by Tawny Garrett on June 21, 2008.
7. The committee did not request a public hearing or submit notarized testimony in lieu of a public hearing.
8. The secretary has record of no previous insufficient filings during the two-year period beginning September 15, 2005.

#### ULTIMATE FINDINGS OF FACT

John Swanson, Treasurer, failed to file a sufficient post election contribution and expenditure report for the May 16, 2006, Primary Election.

#### CONCLUSIONS OF LAW

John Swanson's failure to file a sufficient post election contribution and expenditure report for the May 16, 2006, Primary Election violated ORS 260.063, ORS 260.083 and OAR 165-012-0005. A civil penalty may be imposed for this violation under ORS 260.232(1)(b).

A maximum \$10,000 civil penalty may be imposed for this violation. The *2006 Campaign Finance Manual*, which contains a penalty calculation matrix on pages 108 and 109, is designated in OAR 165-012-0005 as the procedure manual for Oregon campaign finance regulations.

Since this is the first violation by the treasurer, the penalty is \$10.00 per omission.

#### ORDER

It is ordered that a penalty of \$60.00 (\$10.00 X 6 items) is assessed. If your payment is not received within 60 days, the Order will be forwarded to our accounting division for collection and may subsequently be sent to the Oregon Department of Revenue.

Please refer to case number I9443 when mailing your payment.

### RIGHT TO JUDICIAL REVIEW

You have the right to appeal this Order to the Oregon Court of Appeals pursuant to ORS 183.482. To appeal you must file a petition for judicial review with the Court of Appeals within 60 days from the day this Order was served to you. Because this Order was mailed to you, the date of service is the day it was *mailed*, not the day you received it. If you do not file a petition for judicial review within the 60-day time period, you will lose your right to appeal.
