Dear Representative Krieger:

This is a Final Order by Default issued by the Secretary of State (secretary) for your failure to file a timely post-election contribution and expenditure report for the May 18, 2004, Primary Election.

On November 22, 2004, the secretary notified Wayne Krieger for State Representative (committee), pursuant to ORS 260.232(2), that it had failed to file the report and that the secretary may impose a civil penalty. An opportunity for a hearing was provided in that notice; however, no request for a hearing was received by the secretary within the time permitted in the notice. Accordingly, after consideration of the records and files of the secretary regarding this matter, the secretary is entering the following Order.

FINDINGS OF FACT

1. The committee's Statement of Organization (SEL 220), applicable during the reporting period, was filed with the secretary on March 11, 2004. The mailing address provided on the Statement of Organization for the candidate was 95702 Skyview Ranch Rd, Gold Beach, OR 97444. The statement reported Colleen Krieger as the treasurer and 11855 SW Katherine St, Tigard, OR 97223-3145 as the address to which all committee correspondence was to be sent.
2. The committee was required to file a post-election report with the secretary on June 17, 2004.
3. The secretary received the report on June 21, 2004, which is two business days after the date on which the report was due.

4. The committee reported total contributions of \$1,320.00 and total expenditures of \$900.00 during the accounting period for the report.
5. On November 22, 2004, the secretary sent the committee a Notice of Proposed Civil Penalty. The notice was sent by both certified and first class mail to the candidate and was sent by first class mail to the treasurer at the above-referenced addresses. The notice proposed a civil penalty of \$79.20 and allowed the committee 20 days to request a hearing. The notice sent by certified mail was received and signed for by Colleen Krieger on November 24, 2004.
6. It was brought to the attention of the secretary (via phone call from Colleen Krieger) that the penalty for this late report was incorrectly calculated, as this was the candidate's first late violation, not a second violation. Therefore, the correct calculated penalty is \$26.40 ($\$1,320.00 \times 1\% \times 2 \text{ days}$).
7. The committee did not request a public hearing or submit notarized testimony in lieu of a public hearing.
8. The secretary has record of no previous late filings during the two-year period beginning September 15, 2003.

ULTIMATE FINDINGS OF FACT

Wayne Krieger, Candidate, and Colleen Krieger, Treasurer, failed to file a timely post-election contribution and expenditure report for the May 18, 2004, Primary Election.

CONCLUSIONS OF LAW

Candidate Wayne Krieger's and Treasurer Colleen Krieger's failure to file a timely post-election contribution and expenditure report for the May 18, 2004, Primary Election violated ORS 260.058.

By statute, a maximum \$10,000 civil penalty may be imposed for this violation. The *2004 Campaign Finance Manual*, which contains a penalty calculation matrix on pages 101 and 102, is designated in OAR 165-012-0005 as the procedure manual for Oregon campaign finance regulations.

Under the penalty matrix, the maximum statutory penalty of \$10,000 is reduced to 1% of the total contributions or total expenditures—whichever is greater—for each business day the report was late as this is the first late violation by the candidate.

The calculated penalty for the late report is \$26.40 ($\$1,320.00 \times 1\% \times 2 \text{ days}$). Because the appropriate penalty is under \$50, no penalty will be assessed.

ORDER

It is ordered that no penalty be assessed.

RIGHT TO JUDICIAL REVIEW

You have the right to appeal this Order to the Oregon Court of Appeals pursuant to ORS 183.482. To appeal you must file a petition for judicial review with the Court of Appeals within 60 days from the day this Order was served to you. Because this Order was mailed to you, the date of service is the day it was *mailed*, not the day you received it. If you do not file a petition for judicial review within the 60-day time period, you will lose your right to appeal.
