The report was prepared and submitted on September 27, 2004 via email as required. I have attached a copy of my email with the submission. On September 28, 2004, I received a phone call from Jennifer at the Secretary of State – Elections office saying that our report had not been filed. I explained that I did indeed file the report. As we were talking on the phone, and I was getting upset to the point of tears, we determined that the email address that I had sent it to was incorrect. I sent it to sos@state.or.us and it should have been sent to elecfile.sos@state.or.us. There was no email ever received telling me that my email was undeliverable or anything and since this was the first time I had ever filed an electronic report, I was unaware that I should have received a confirmation of receipt from your office. I emailed the report to the address on my instruction sheet that printed out from my software and was unaware that the email address was incomplete.

I have attached copies of everything I have documenting this issue. In my opinion, I did submit on a timely basis with the information that I had at that time. There have been no other reports considered by your office to have been filed late since that date and request that there be no penalties assessed.
