TESTIMONY: I did not submit this report one day late. It arrived at Room 141 one day late because Federal Express delivered to the wrong room at the State Capitol, even though it was properly addressed.

Attached is a copy of the Federal Express label received by them on 10/20/04 addressed to "Oregon Secretary of State, 141 State Capitol, Room 141, Salem, OR 97310-0722. Federal Express guaranteed next day delivery on this parcel.

On 10/22/04, I was informed that the Elections Division web page indicated the report was one day late.

On 10/22/04, I spoke with Elections Division representatives at least three times during the afternoon. They confirmed that Federal Express delivered the envelope to the main mail room at the State Capitol, in error, as it was properly addressed to Room 141. Your telephone records should reflect that I was told, by Jan, I believe, that the error was not mine and the report would not be designated late, but the matter might be reviewed in the future. This appears to be that review.

Note that the delivery was made to the main mail room on time, on 10/21/04.

Therefore, even if the report was designated as received late, the penalty should be waived pursuant to "Reduction or Waiver of Penalty" paragraph c):

"The lateness was the direct result of failure of a professional delivery service to deliver the documents in the time guaranteed." Although the delivery was made on time, the error was due to the delivery service leaving it at the wrong location, rather than at the wrong time.


