Dear Senator Westlund:

This is a Final Order by Default issued by the Secretary of State (secretary) for your failure to file a timely second pre-election contribution and expenditure report for the May 16, 2006, Primary Election.

On August 14, 2006, the secretary notified the Committee to Elect Ben Westlund (committee), pursuant to ORS 260.232(2), that it had failed to file the report and that the secretary may impose a civil penalty. An opportunity for a hearing was provided in that notice; however, no request for a hearing was received by the secretary within the time permitted in the notice. Accordingly, after consideration of the records and files of the secretary regarding this matter, the secretary is entering the following Order.

FINDINGS OF FACT

1. The committee's Statement of Organization (SEL 220), applicable during the reporting period, was filed with the secretary on April 12, 2006. The mailing address provided on the Statement of Organization for the candidate was PO Box 1379, Bend, OR 97709. The statement reported Dana Billingsley as the treasurer and PO Box 1540, Bend, OR 97709-1540 as the address to which all committee correspondence was to be sent.
2. The committee was required to file a second pre-election report with the secretary on May 4, 2006.
3. The secretary received the report on May 5, 2006, which is one business day after the date on which the report was due.

4. The committee reported total contributions of \$76,154.54 and total expenditures of \$61,211.01 during the accounting period for the report.
5. On August 14, 2006, the secretary sent the committee a Notice of Proposed Civil Penalty. The notice was sent by both certified and first class mail to the candidate at the above-referenced address. The notice proposed a civil penalty of \$761.55 and allowed the committee 20 days to request a hearing. The notice sent by certified mail was received and signed for by Devlin Timony-Balyeat on August 17, 2006.
6. On September 18, 2006, the secretary received an amended SEL 220 updating the mailing address for the candidate and committee to 20590 Arrowhead Dr, Bend, OR 97701.
7. The committee did not request a public hearing or submit notarized testimony in lieu of a public hearing.
8. The secretary has record of no previous late filings during the two-year period beginning September 15, 2005.

ULTIMATE FINDINGS OF FACT

Ben Westlund, Candidate, and Dana Billingsley, Treasurer, failed to file a timely second pre-election contribution and expenditure report for the May 16, 2006, Primary Election.

CONCLUSIONS OF LAW

Candidate Ben Westlund's and Treasurer Dana Billingsley's failure to file a timely second pre-election contribution and expenditure report for the May 16, 2006, Primary Election violated ORS 260.058.

By statute, a maximum \$10,000 civil penalty may be imposed for this violation. The *2006 Campaign Finance Manual*, which contains a penalty calculation matrix on pages 104–106, is designated in OAR 165-012-0005 as the procedure manual for Oregon campaign finance regulations.

Under the penalty matrix, the maximum statutory penalty of \$10,000 is reduced to 1% of the total contributions or total expenditures—whichever is greater—for each business day the report was late as this is the first late violation by the candidate.

ORDER

It is ordered that a penalty of \$761.55 ($\$76,154.54 \times 1\% \times 1 \text{ day}$) is assessed. If your payment is not received within 60 days from the date of service noted below, this Order will be sent to our accounting division for collection and may be subsequently sent to the Oregon Department of Revenue.

Please refer to case number L8762 when mailing your payment.

RIGHT TO JUDICIAL REVIEW

You have the right to appeal this Order to the Oregon Court of Appeals pursuant to ORS 183.482. To appeal you must file a petition for judicial review with the Court of Appeals within 60 days from the day this Order was served to you. Because this Order was mailed to you, the date of service is the day it was *mailed*, not the day you received it. If you do not file a petition for judicial review within the 60-day time period, you will lose your right to appeal.
