I received your Notice of Civil Penalty for the Committee to Elect Jim Torrey that noted the second pre-election report was filed a day late. I respectfully request a waiver of the penalty.

1. I originally submitted the report at 11:16 am on May 4, 2006. I was notified at 2:54 pm that the PC 3 information was incorrect.
2. I reread the specifications for the PC 3 information, made changes and resubmitted the report at 3:51 pm. I was notified at 5:32 pm that evening that the file was incorrect and it was too late to submit a timely report.
3. I worked through the specifications again and resubmitted at 6:28 am on May 5th. This report was accepted at 3:01 on May 5th. The Elections department noted there was an error message in the PC 3 detail record that an invalid value in the "paid to account payable" field. The Elections department posted the report, but indicated this error would be brought up in the exam letter.

I have attached copies of all email correspondence.

The error that was noted in the final correspondence from the Elections office was an incorrect X noting an accounts payable payment instead of the correct notation of Y. Throughout the entire process, I spend considerable time reviewing the file specifications for the PC 3. This was the first electronic PC 3 form I have filed. In the past, when filing this report in paper, an X was noted in the A/P box. The electronic filing is still a new process for me and it is more difficult to review the submission in an ASCII file format than with the actual forms. I missed this notation in my detailed review of the specifications and the detailed line items.

The initial submission was filed on time and I spent considerable time and effort addressing the problem in a timely manner to the best of my abilities. There was a good faith effort in meeting the deadline and submission requirements. In addition, the prior and subsequent reports have been filed timely and any problems addressed within the timeline required.

I respectfully request a waiver of the penalty.
