Dear Representative Berger:

This is a Final Order by Default issued by the Secretary of State (secretary) for your failure to file a timely post-election contribution and expenditure report for the May 16, 2006, Primary Election.

On December 7, 2006, the secretary notified Friends of Vicki Berger (committee), pursuant to ORS 260.232(2), that it had failed to file the report and that the secretary may impose a civil penalty. An opportunity for a hearing was provided in that notice; however, no request for a hearing was received by the secretary within the time permitted in the notice. Accordingly, after consideration of the records and files of the secretary regarding this matter, the secretary is entering the following Order.

FINDINGS OF FACT

1. The committee's Statement of Organization (SEL 220), applicable during the reporting period, was filed with the secretary on November 30, 2005. The statement reported Chuck Swank as the treasurer and 805 Kingwood Dr NW, Salem, OR 97304 as the mailing address for both candidate and committee correspondence.
2. The committee was required to file a post-election report with the secretary on June 15, 2006. This report was required to be filed electronically. A paper copy of the report was provided to the secretary on June 14, 2006.
3. The secretary received the electronic filing of the report on June 16, 2006, which is one business day after the date on which the report was due.

4. The committee reported total contributions of \$2,900.00 and total expenditures of \$2,041.53 during the accounting period for the report.
5. On December 7, 2006, the secretary sent the committee a Notice of Proposed Civil Penalty. The notice was sent by both certified and first class mail to the candidate and was sent by first class mail to the treasurer at the above-referenced address. The notice incorrectly proposed a civil penalty of \$87.00, because the secretary failed to account for the fact that a paper copy of the report was received timely. Therefore, the appropriate penalty should be \$21.75. The notice allowed the committee 20 days to request a hearing. The notice sent by certified mail was received and signed for by G. I. Berger on December 8, 2006.
6. The committee did not request a public hearing or submit notarized testimony in lieu of a public hearing.
7. The secretary has record of one previous late filing during the two-year period beginning September 15, 2005.

ULTIMATE FINDINGS OF FACT

Vicki Berger, Candidate, and Chuck Swank, Treasurer, failed to file a timely post-election contribution and expenditure report for the May 16, 2006, Primary Election.

CONCLUSIONS OF LAW

Candidate Vicki Berger's and Treasurer Chuck Swank's failure to file a timely post-election contribution and expenditure report for the May 16, 2006, Primary Election violated ORS 260.058.

By statute, a maximum \$10,000 civil penalty may be imposed for this violation. The *2006 Campaign Finance Manual*, which contains a penalty calculation matrix on pages 104–106, is designated in OAR 165-012-0005 as the procedure manual for Oregon campaign finance regulations.

Under the penalty matrix, the maximum statutory penalty of \$10,000 is reduced to 3% of the total contributions or total expenditures—whichever is greater—for each business day the report was late as this is the second late violation by the candidate. Additionally, if a paper copy of the report is provided to the filing officer prior to the electronic copy, the penalty is reduced by 75%, beginning with the day a paper copy of the report is submitted.

ORDER

The calculated penalty for the late report is \$21.75 ($\$2,900.00 \times 3\% \times 1$ business day late $\times 25\%$). Because the penalty is under \$50, no penalty will be assessed.

Payment of the proposed civil penalty of \$87.00 was received in the office of the Secretary of State on January 3, 2007. The secretary will request a refund to the committee in the amount of \$87.00. It will take 2 – 3 weeks to process this request.

This order will serve as your receipt and this matter is now considered closed.

RIGHT TO JUDICIAL REVIEW

You have the right to appeal this Order to the Oregon Court of Appeals pursuant to ORS 183.482. To appeal you must file a petition for judicial review with the Court of Appeals within 60 days from the day this Order was served to you. Because this Order was mailed to you, the date of service is the day it was *mailed*, not the day you received it. If you do not file a petition for judicial review within the 60-day time period, you will lose your right to appeal.
