TESTIMONY: To Oregon Secretary of State, Elections Division:

In reference to Case Number L9079, I am providing a written explanation and supporting documents to the circumstance that has resulted in a proposed civil penalty and violation against Paul Holvey for State Representative Committee 4788; and I am also asking that the penalty for violation be waived. The proposed penalty and violation results from a contribution of \$5000 from Pacific Northwest Regional Council of Carpenters Separate Segregated Fund check number 2316 dated 05/08/2006, and was reported in the 2006 Primary Post Election Report with a received date of 05/11/2006. The 05/11/2006 date was incorrect due to a data entry error in the electronic reporting system and was actually received 05/12/2006. An amendment correcting this error has been filed with the Secretary of State Elections Division. The check was deposited 05/15/2006. A copy of the check, stub, deposit slip, and ledger sheet are included with this explanation. My committee received an Exam Letter dated 06/30/2006 stating the 2006 Primary Post Election report from my committee was sufficient. Since that date, no notification or determination that any statement relating to the 2006 Primary Election was insufficient was communicated to myself or the committee until receiving the Notice of Proposed Civil Penalty dated 11/30/2006. Since the data error has been corrected in an amended statement according to ORS 260.159 and the proposed civil penalty by the Office of the Secretary of State is not compliant with the legislative intent of Oregon Revised Statutes Chapter 260, including ORS 260.205, ORS 260.215, and ORS 260.232, constitute mitigating circumstances and I respectfully request the proposed civil penalty and violation be waived and dismissed.


